### RECORD BOOK PROCESS & DATES

The purpose of a record book is to: 1) set goals for yourself; 2) share and record what you've learned; 3)



reflect on accomplishments or give thought to how you may or may not do something differently next time. It is also the current way to apply for several countywide awards. Record books are not associated with fair checks in any way. Please see the "My Record Book Guide" and "Record Book Check Sheet" that will be included in your leader's County Fair packet. Be careful to include all activities you participated in. Merit in a project is achieved by going above and beyond, such as giving a talk or demonstration on the topic or helping others learn the project by providing education or help. Upon completion of your record book, turn it into your club leader. He or she will complete the Record Book Check Sheet or you can complete it together.

Record Book Due Date & Judging Schedule: Record books are due to your club general leader at a date he or she specifies. General leaders must have record books (with completed 4-H Member & Leaders Record Book Check Sheet and "Marinette County 4-H Award Nominations" sheet [given to leaders in club fair packet]) to the 4-H Office by 4:30 p.m. on Tues., October 1st. If you are judging, books may be brought in with you on Thurs., October 3rd. Judging begins at 5:00 (or whatever time you can attend) in the Resource Center Conference Room. One leader or parent from each club is asked to help with judging. Food will be provided by the 4-H Leaders Assoc., but you must call the 4-H office by Tuesday noon to let them know if you are coming and if you have any dietary restrictions.

## REMINDER FOR CLUB GENERAL LEADERS CLUB ANNUAL FINANCIAL REPORTS (AFRs) DUE SEPTEMBER 1

As in past years, all 4-H Clubs and Groups that have a checking and/or savings account must complete and submit the following documents to their 4-H Program Educator by September 1: Wisconsin 4-H Clubs & Groups Annual Financial Report; Wisconsin 4-H Clubs & Groups Audit Checklist; A copy of the checkbook and/or savings registry covering July 1 – June 30; A copy of the bank statement ending June 30 or July 1 for each account. Any differences between the bank statement(s) and the ending balance reported must be reconciled and the reconciliation must be uploaded with the Annual Financial Report; A current inventory of land, buildings, property, or project equipment with individual values of \$2,000 or greater; and Monthly Treasurer's Reports for 4-H Clubs or Groups with annual income greater or equal to \$20,000.

This process allows the 4-H Club or Group to qualify for federal tax-exempt status under the University of Wisconsin Board of Regents General Exemption Number (GEN) for Wisconsin 4-H Clubs and Groups.

### COUNTY 4-H YOUTH ATTENDED SUMMER ACADEMY

In June, youth from across Wisconsin gathered at the UW-Madison campus for the annual Summer Academy event, hosted by UW-Madison Extension's Positive Youth Development Institute and 4-H. At Summer Academy, youth had the opportunity to build and learn skills to reach goals and plan for the future. Youth participants explored careers, college and other topics of interest through interactive workshops. They developed positive connections with other youth and adults through small and large groups activities.

Youth participants chose one of 6 college/career track options to explore: agriculture, expressive arts, health, baking, transportation, or biological sciences. Tracks were led by faculty & staff at both UW-Madison and Madison Area Technical College. Youth participants engaged in goal setting and visualization activities to help them make plans for their future. Youth leadership was also front & center, with our WI Leadership Council youth leading small groups and supporting participants throughout the experience.

There was, of course, lots of time for fun, too. Some of the most popular event elements were the Makerspace evening, recreation options hosted by Outdoor UW on Lake Mendota, team trivia, a dance, and the Art Team Art Show + Drama Company performance. All of these special events made for a very memorable week.

Take a photo of your display for judging ... may take it before putting the display in the window to avoid a possible glare. The 4-H Leaders Association gives \$10 towards costs.

### 2024-25 PROJECT YEAR BEGINS OCT. 1

Our new enrollment year for 2025 begins on October 1.

Members and leaders must re-enroll each year by November 30. Regular members must be in 3rd grade or older.

Cloverbuds (children in 5K through 2nd grade) should be listed in your club enrollment. Cloverbuds can participate in club activities. They can exhibit at the County Fair, only in the Cloverbud category, and do not receive premiums.

Re-enrollment deadline is November 30, 2024.

- \*New members can join at any time, but must enroll by May 1 to enter in the Fair.
- \*May 1 is also the deadline to add or drop projects.
- \*You must be enrolled in a project in order to exhibit at the Fair in that project.

We hope that your 4-H club will have a special promotion to tell the benefits of 4-H in your respective communities this fall. Invite your friends to join!!

### **4-H TRIPS**

Teens interested in attending trips should fill out the Marinette County Sponsored Event Application. First round is due Oct. 1. All information regarding age requirements and trips will be included in the leaders packet at the Fair. Following that, applications are due Feb. 1 and with interviews at the Feb. 4-H Association Meeting.

### **FAIR PASSES**

Family Fair Passes for families of youth exhibitors are still \$25 per family. Each club needs to collect a list (club name and members of each family living in the house) and money to turn into the 4-H Office no later than August 5. NOTE: The Family Pass only includes immediate family members living in the same household. Please make checks payable to: Marinette County Fair.

### MEAL TICKET INFO FOR FOOD STAND

Meal tickets are still \$50 this year. Only youth exhibitors (including FFA) and leaders will be able to purchase meal tickets. Parents of the youth exhibitors will not be able to purchase them unless they are leaders. Please make checks payable to: Marinette County 4-H.

- •There is no breakfast included this year.
- •Lunch and dinner will need to be used on the <u>same day</u> assigned. They will need to be used up by 9:00 pm of that day and 4:00 pm on Sunday. NOTE: There will be <u>NO sharing</u> of meal passes.



## FOOD STAND DRESS ETIQUETTE - FROM THE FOOD STAND COMMITTEE

Hats must be worn and hair pulled back. Do not wear flip flops, sandals, short shorts nor mini skirts. Comfortable closed toe shoes should be worn. T-shirts or sleeved shirts must be worn; NO spaghetti straps permitted.

### MEMBERS WORKING AT FOOD STAND

Members **must work a full shift** or more or contact the Extension office to do alternative positions to receive some of the awards or travel. The basic guidelines are as follows (Parents should not work a member's shift for the member to receive the credit):

- 1. 4-H members (3<sup>rd</sup> grade and up) are encouraged to work a shift in the food stand.
- 2. Members purchasing meal passes must work a full shift in the food stand.
- 3. Members participating in the county-sponsored event form activities must work a full shift in the food stand and are strongly encouraged to work an extra shift at the fair or help with set up on Wednesday before the Fair or clean up on Sunday evening of the Fair or, if needed, during the Fair.
- 4. Clubs should wait at the back door of the food stand when their shift will be starting to get instructions from the food stand manager before the shift starts.
- 5. All members/people working in the stand need to be working during their shift. You need to eat before or after your shift, no leaving during your shift to eat.
- 6. Drinks are not free while you are working in the stand or at any other time.

REMEMBER: NO DRINKING/EATING DURING YOUR SHIFT.

Take care to fill out food stand sign-up sheets as they will be checked after the Fair to verify volunteer obligations. If you are not available to help during your club's shift at the food stand, contact the 4-H office for an alternative volunteer opportunity.

Shifts available to clubs to work at the Food Stand can be found at the end of this newsletter. On Wednesday, August 21, will have limited menu.



### COUNTY FAIR ENTRIES TO BE BROUGHT A DAY EARLIER AGAIN

Entry times will be from 12-8 pm on Wednesday, August 21, for non-animal items, rabbit/poultry entry times will be 4-7 pm, and all other animals will be 9 am-12 pm on Thursday, August 22. Face to face judging will take place from noon until 8 pm on Wed.

### YOUTH CLUB FLOWER DISPLAYS

An entry consists of two pots with flowers planted in them. Each club may have one entry. They will be judged on Wed., Aug. 21.

### <u>VET SCIENCE, EXOTIC ANIMALS, DOG, CAT, POCKET PETS (NOT RABBITS)</u>

Dogs, caged birds, guinea pigs, hamsters, and cat projects will be judged face-to-face the Saturday before the Fair, on *August 17*, at the Fairgrounds.

### **DAIRY AND BEEF EXHIBITORS**

Please call the Superintendents, either Troy VanDe-Walle at 715-938-4014 or Dave VanDeWalle at 715-927-3838, no later than the first Saturday in August with the exact number of animals you will be showing.

### **FACE TO FACE JUDGING**

Face-to-face judging provides an opportunity for the youth to communicate with the judge (one-on-one) on details of his or her exhibit. This judging style gives the judge the opportunity to directly ask questions. It provides an opportunity to understand why the exhibit was selected for construction, if there were any problems with it & tools used to create the exhibit. The judge can then use this discussion to decide the placing.

### PREPARING YOUR ITEMS TO EXHIBIT

Be sure to read the rules in the Fair premium listing. Entry tags need to be securely attached before judging. Remove and keep the bottom part of the entry tag. It is used as a claim check to pick up your items on Sunday at 5 p.m.

### **ATTENTION ANIMAL EXHIBITORS**

- ■When entering your animal for the Fair, also list a nonanimal exhibit or poster in that particular project, in case your animal gets sick so that you can still have something entered.
- ■If you are showing two or more different animals, talk to the Superintendents involved so that classes can be adjusted for everyone to exhibit.
- ■If you are a dairy, livestock &/or horse exhibitor, please remember to keep trash out of the manure at the Fair. This inc. cans, paper cups, twine, wire, medication containers & needles. Please use the trash barrels in the barns.

### **CLOVERBUDS**

These young members do not need to submit entry forms to show at the Fair. They do need to fill out a 3"x5" card w/name, age, club, & item being entered, and take it to the Clothing Bldg. Cloverbuds will have face-to-face judging from noon to 8 pm on Wed. or you can drop off the items without seeing the judge. Cloverbuds may enter up to eight items.

### **CAMPING NEAR THE FAIRGROUNDS**

4-H families wanting to camp during the Fair may call the Village Clerk at 715-856-5341 to camp at Evergreen Park, in Wausaukee. The park is across the creek on the north side of the Fairgrounds.

Motion to adjourn at 7:05pm by Deb Heitman, second by Julia Lepinski. Carried


