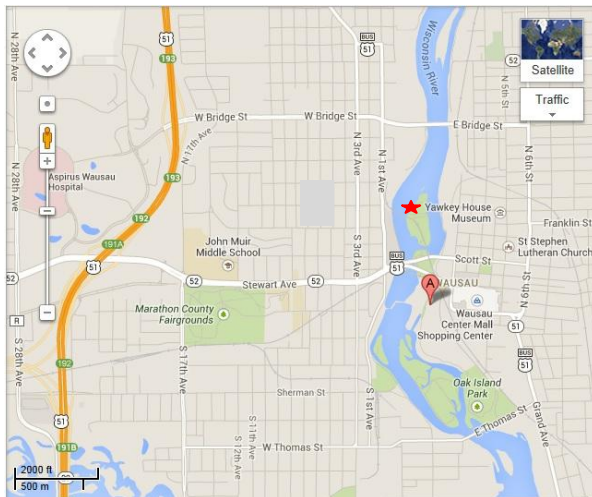


Dear Dairy Processors & Veterinarians,
