There is no doubt summer has arrived! I hope you are all staying cool and enjoying it to the fullest! I am so happy to share that there has been some big changes to the 4-H COVID policy lately. In case you have not seen the updates from the state, please review our most current policy here:

Wisconsin 4-H COVID-19 Policy (Updated June 2, 2021)

Effective June 2, all fully vaccinated Wisconsin 4-H staff, volunteers and participants are no longer required to wear masks during programs. We ask that individuals who are not fully vaccinated, including youth under 12, continue to wear masks. Staff and volunteers will not enforce mask wearing or ask for proof of vaccination for those not wearing masks. Masks may still be worn if preferred and individual masking choices should not be interpreted as an indicator of vaccination status.

- Outdoors: Physical distancing is no longer required outdoors for vaccinated people. Individuals who are not vaccinated should maintain 6 feet of physical distancing and, if physical distancing is not possible, wear a face covering.
- Indoors: There are no group size limits on indoor gatherings as long as a minimum of 6 feet of physical distancing is able to be maintained, regardless of vaccination status.
- Transportation: Any individual who is not vaccinated should wear a face covering when driving or riding with others. Vehicle occupancy is recommended to be no more than 50 percent of capacity when traveling with an unvaccinated individual(s).

This updated policy applies to all Wisconsin 4-H programs including overnight programs, 4-H programs at county fairs and food stands.

As a reminder, Wisconsin 4-H staff, volunteers and participants should continue to follow local public health guidance.

Important notes for volunteers regarding the new guidance:

- The program approval request form is no longer required for meetings and/or events. If you are having a meeting/ event outside of your typical meeting schedule please let me know via phone or email prior to the date.
- Attendance records are no longer needed in the 4-H office. Please continue to keep your club attendance records for yourself as you normally would.
- Any request for the use of bussing for any event must be made to me well in advance of the event to follow the appropriate request and approval process.

I trust that each family will continue to make the best decision to keep each other safe and healthy this summer while enjoying so many of the things we may have missed last year. I am looking forward to seeing all of you more this year!

FAIR NEWS

FAIR PASSES

Family Fair Passes for families of youth exhibitors are still \$25 per family. Each club needs to collect a list (club name and members of each family living in the house) and money to turn into the 4-H Office no later than August 5. NOTE: The Family Pass only includes immediate family members living in the same household. Please make checks payable to: <u>Marinette County Fair</u>.

FOOD STAND DRESS ETIQUETTE - FROM THE FOOD STAND COMMITTEE

Hats must be worn and hair pulled back. Do not wear flip flops, sandals, short shorts nor mini skirts. Comfortable closed toe shoes should be worn. T-shirts or sleeved shirts must be worn; NO spaghetti straps permitted.

MEMBERS WORKING AT FOOD STAND

Members must work a full shift or more or contact the Extension office to do alternative positions to receive some of the awards or travel. The basic guidelines are as follows (Parents should not work a member's shift for the member to receive the credit):

1. 4-H members (3rd grade and up) are encouraged to work a shift in the food stand.

2. Members purchasing meal passes must work a full shift in the food stand.

3. Members participating in the county-sponsored event form activities must work a full shift in the food stand and are strongly encouraged to work an extra shift at the fair or help with set up on Wednesday before the Fair or clean up on Sunday evening of the Fair or, if needed, during the Fair.

4. Clubs should wait at the back door of the food stand when their shift will be starting to get instructions from the food stand manager before the shift starts.

 All members/people working in the stand need to be working during their shift. You need to eat before or after your shift, no leaving during your shift to eat.
Drinks are not free while you are working in the stand or at any other time.

REMEMBER: NO DRINKING/EATING DURING YOUR SHIFT.

Take care to fill out food stand sign-up sheets as they will be checked after the Fair to verify volunteer obligations. If you are not available to help during your club's shift at the food stand, contact the 4-H office for an alternative volunteer opportunity.

Shifts available to clubs to work at the Food Stand can be found at the end of this newsletter. Help is also needed on Wednesday, August 25; will have limited menu.

YOUTH CLUB FLOWER DISPLAYS

An entry consists of two pots with flowers planted in them. Each club may have one entry. They will be judged on Wed., Aug. 25.

IMPORTANT CHANGE IN DATES/ TIMES FOR BRINGING EXHIBITS

All non-animal exhibits will be entered on *Wed., Aug. 25*, between the hours of noon and 8 pm. Face-to-face judging will take place during this time for junior fair entries. All animals will be brought to the Fair on *Thurs., Aug 26,* between the hours of 9 am and noon.

VET SCIENCE, EXOTIC ANIMALS, DOG, CAT, POCKET PETS (NOT RABBITS)

Dogs, caged birds, guinea pigs, hamsters, and cat projects will be judged face-to-face the Saturday before the Fair, on *August 21*, at the Fairgrounds.

DAIRY AND BEEF EXHIBITORS

Please call the Superintendents, either Troy VanDeWalle at 715-938-4014 or Dave VanDeWalle at 715-927-3838, no later than the first Saturday in August with the exact number of animals you will be showing.

FACE TO FACE JUDGING

Face-to-face judging provides an opportunity for the youth to communicate with the judge (one-on-one) on details of his or her exhibit. This judging style gives the judge the opportunity to directly ask questions. It provides an opportunity to understand why the exhibit was selected for construction, if there were any problems with it & tools used to create the exhibit. The judge can then use this discussion to decide the placing.

ATTENTION ANIMAL EXHIBITORS

When entering your animal for the Fair, also list a non-animal exhibit or poster in that particular project, in case your animal gets sick so that you can still have something entered.

If you are showing two or more different animals, talk to the Superintendents involved so that classes can be adjusted for everyone to exhibit.

■If you are a dairy, livestock &/or horse exhibitor, please remember to keep trash out of the manure at the Fair. This inc. cans, paper cups, twine, wire, medication containers & needles. Please use the trash barrels in the barns.

CLOVERBUDS

These young members do not need to submit entry forms to show at the Fair. They do need to fill out a 3"x5" card w/name, age, club, & item being entered, and take it to the Clothing Bldg. Cloverbuds will have face-to-face judging from noon to 8 pm on Wed. or you can drop off the items without seeing the judge. Cloverbuds may enter up to eight items.

CAMPING NEAR THE FAIRGROUNDS

4-H families wanting to camp during the Fair may call the Village Clerk at 715-856-5341 to camp at Evergreen Park, in Wausaukee. The park is across the creek on the north side of the Fairgrounds.

PREPARING YOUR ITEMS TO EXHIBIT

Be sure to read the rules in the Fair premium listing. Entry tags need to be securely attached before judging. Remove and keep the bottom part of the entry tag. It is used as a claim check to pick up your items on Sunday at 5 p.m.

FAIR ENTRY FORMS

Each 4-H family should have received their youth entry forms and a premium book in the mail. Remember, the deadline to enter youth entries and open animal entries is July 7th.

MECHANICAL SCIENCES

YOUTH TRACTOR/MACHINERY SAFETY CERTIFICATION TRAINING OFFERED

The Marinette and Oconto offices of UW-Madison, Division of Extension, are offering certification training for the youth Tractor & Machinery Safety permit. Youth that are between the ages of 12 and 16 need to have this certification to be able to legally drive any type of farm implement or tractor on public roadways when working for their family farms, or other farms after the age of 14. Youth not having a driver's license should also have the certification for farm insurance purposes.

Training will be conducted at three in-person instruction days, plus self study of the materials. Scott Reuss, Agriculture Agent, will be leading the course and overseeing students at the testing and skills building portions. There is a registration fee of \$40, which includes all course training materials. Registration is required. To register, e-mail the students' name, mailing address, contact phone number, and student and parent e-mail addresses to scott.reuss@wisc.edu Reuss will send an invoice for the registration fee along with forms which need to be signed to begin the course. You can also request a registration form by calling Reuss at 715-732-7510, or watch for it in the agriculture newsletter.

Training dates are *Tuesday, July 13; Tuesday, July 20*; and the testing and skills reviews will be conducted on *Thursday, July 22nd*. Each day of in-person training starts at 9 a.m. and lasts until 3 p.m. and will take place at the Pound Town Hall on the east edge of Coleman. State law requires that youth need to be 12 by the date of the testing to be eligible for the certificate. If you have any questions about eligibility or requirements for training, or the course methodology this year, contact Scott Reuss as above.

To be eligible, pre-registration must be submitted to the WI 4-H office via 4-H Online by June 1. The individual must be a 4-H club member and in grades 3-13.

Registration fees will be \$12 per participant and will need to be paid by credit card through 4HOnline or by check on the day of the event. Checks should be made payable to UW-Madison Extension. No refunds will be given if the participant has paid and can't make the event. All participants will need to pay the registration fee.

Schooling Pleasure Show: July 17th at the Fairgrounds! A schooling show is like a clinic in that members will show their horses in various classes and then receive immediate feedback from an experienced judge about how to improve their performance. Grooming and tack for the horses and the apparel for the riders are the same as for a regular show, and ribbons will be awarded. For those who are new to showing, or are trying out a new class, this is a great opportunity! It's also a time for parents to be involved: we need plenty of help to run a show! We are fortunate to have Rebecca Barrett returning as our judge. Rebecca is a 4-H alumna and a great teacher. Even if you do not show on this day, come and learn!



More open arena time at the fairgrounds: Pending approval from the Fair Board, we have two

dates planned for members who would like to ride in the arena. The gates will be open at 6-8 p.m. on Tuesday, June 29th and Wednesday, July 28th. Remember, your Coggins is required. Once we have seen the original and have a copy, you do not need to bring the Coggins again until Fair time. Again, for new members especially, this is a good way to become familiar with the arena with your horse.

COGGINS TEST REQUIRED FOR HORSES

All horses must have the current calendar year Coggins test to exhibit at the county fair and state horse show.

Horses showing any symptoms of contagious or infectious disease will NOT be permitted to exhibit. Check other rules and regulations in the Fair Premium List.

REMEMBER the 4-H Fair Food Stand is one of the main sources of income for 4-H. Each club must sign up for at least one shift. Clubs with only young members and/or few members should sign up for the early morning shifts or work with another club. LARGER CLUBS ARE ASKED TO TAKE BUSIER SHIFTS, FRIDAY & SATURDAY. Exploring 4-H for New Families



Making Memories at the Fair



Going to and exhibiting at the fair is often a major highlight for 4-H youth. For some youth, that may be participating in their community, county, or regional fair. For others, that may mean exhibiting at the Wisconsin State Fair. No two fairs are the same, but they do share the opportunity for 4-H members to show their accomplishments.

Who organizes the fair?

The Wisconsin Association of Fairs and DATCP (Department of Agriculture, Trade and Consumer Protection), gives leadership to county fair boards and associations. Those local entities are responsible for organizing the fair. Most fairs have volunteers who serve in roles called superintendents. They serve as a valuable link between the fair and the exhibitors to make sure judging goes smoothly and answer questions related to exhibit scoring. Please be kind to the superintendent—they freely give their time to help the fair and your child.

How to help your 4-H member find success

- Be prepared. Read the premium book and get to know fair entry rules for your 4-H member's exhibits. Check with your local fair for their premium book and exhibitor rules.
- Make it educational. Ask your 4-H member questions about their project(s). Helping youth reflect on their work can also help them prepare to exhibit.



- Keep everything in perspective and be supportive. Even if the color of the ribbon wasn't what your exhibitor was looking for, you can help them focus on what they learned in the process.
- Have fun and make memories! The fair is full of opportunities that will stick with your family for a long time. Adults can help make sure that it is a positive experience for youth.
