

FAIR PASSES

Family Fair Passes for families of youth exhibitors are still \$25 per family. Each club needs to collect a list (club name and members of each family living in the house) and money to turn into the 4-H Office no later than August 4. NOTE: The Family Pass only includes immediate family members living in the same household. Please make checks payable to: Marinette County Fair.

FOOD STAND DRESS ETIQUETTE - FROM THE FOOD STAND COMMITTEE

Hats must be worn and hair pulled back. Do not wear flip flops, sandals, short shorts nor mini skirts. Comfortable closed toe shoes should be worn. T-shirts or sleeved shirts must be worn; NO spaghetti straps permitted.

MEMBERS WORKING AT FOOD STAND

Members must work a full shift or more or contact the Extension office to do alternative positions to receive some of the awards or travel. The basic guidelines are as follows (Parents should not work a member's shift for the member to receive the credit):

- 1. 4-H members (3rd grade and up) are encouraged to work a shift in the food stand.
- 2. Members purchasing meal passes must work a full shift in the food stand.
- 3. Members participating in the county-sponsored event form activities must work a full shift in the food stand and are strongly encouraged to work an extra shift at the fair or help with set up on Wednesday before the Fair or clean up on Sunday evening of the Fair or, if needed, during the Fair.
- 4. Clubs should wait at the back door of the food stand when their shift will be starting to get instructions from the food stand manager before the shift starts.
- 5. All members/people working in the stand need to be working during their shift. You need to eat before or after your shift, no leaving during your shift to eat.
- 6. Drinks are not free while you are working in the stand or at any other time.

REMEMBER: NO DRINKING/EATING DURING YOUR SHIFT.

Take care to fill out food stand sign-up sheets as they will be checked after the Fair to verify volunteer obligations. If you are not available to help during your club's shift at the food stand, contact the 4-H office for an alternative volunteer opportunity.

Shifts available to clubs to work at the Food Stand can be found at the end of this newsletter. Help is also needed on Wednesday, August 23; will have limited menu.

COUNTY FAIR ENTRIES TO BE BROUGHT A DAY EARLIER AGAIN

Entry times will be from 12-8 pm on **Wednesday**, **August 23**, for non-animal items and animals will be 9 am- 12 pm on **Thursday**, **August 24**. Face to face judging will take place from noon until 8 pm on Wed.

YOUTH CLUB FLOWER DISPLAYS

An entry consists of two pots with flowers planted in them. Each club may have one entry. They will be judged on Wed., Aug. 23.

<u>VET SCIENCE, EXOTIC ANIMALS, DOG, CAT, POCKET PETS (NOT RABBITS)</u>

Dogs, caged birds, guinea pigs, hamsters, and cat projects will be judged face-to-face the Saturday before the Fair, on *August 19*, at the Fairgrounds.

DAIRY AND BEEF EXHIBITORS

MEAL TICKET INFO FOR FOOD STAND

Meal tickets are still \$50 this year. Only youth exhibitors (including FFA) and leaders will be able to purchase meal tickets. Parents of the youth exhibitors will not be able to purchase them unless they are leaders. Please make checks payable to: Marinette County 4-H.

- •Breakfast will be served from 7:30-10:00 am at the south window by the soda. Cold cereal, boiled eggs, milk & fruit will be served for breakfast only. "Breakfast" is for breakfast only.
- •Lunch and dinner also will need to be used on the <u>same day</u> assigned. They will need to be used up by 9:00 pm of that day and 4:00 pm on Sunday. NOTE: There will be <u>NO sharing</u> of meal passes.

FACE TO FACE JUDGING

Face-to-face judging provides an opportunity for the youth to communicate with the judge (one-on-one) on details of his or her exhibit. This judging style gives the judge the opportunity to directly ask questions. It provides an opportunity to understand why the exhibit was selected for construction, if there were any problems with it & tools used to create the exhibit. The judge can then use this discussion to decide the placing.

ATTENTION ANIMAL EXHIBITORS

- ■When entering your animal for the Fair, also list a non-animal exhibit or poster in that particular project, in case your animal gets sick so that you can still have something entered.
- ■If you are showing two or more different animals, talk to the Superintendents involved so that classes can be adjusted for everyone to exhibit.
- ■If you are a dairy, livestock &/or horse exhibitor, please remember to keep trash out of the manure at the Fair. This inc. cans, paper cups, twine, wire, medication containers & needles. Please use the trash barrels in the barns.

CLOVERBUDS

These young members do not need to submit entry forms to show at the Fair. They do need to fill out a 3"x5" card w/name, age, club, & item being entered, and take it to the Clothing Bldg. Cloverbuds will have face-to-face judging from noon to 8 pm on Wed. or you can drop off the items without seeing the judge. Cloverbuds may enter up to eight items.

CAMPING NEAR THE FAIRGROUNDS

4-H families wanting to camp during the Fair may call the Village Clerk at 715-856-5341 to camp at Evergreen Park, in Wausaukee. The park is across the creek on the north side of the Fairgrounds.

PREPARING YOUR ITEMS TO EXHIBIT

Be sure to read the rules in the Fair premium listing. Entry tags need to be securely attached before judging. Remove and keep the bottom part of the entry tag. It is used as a claim check to pick up your items on Sunday at 5 p.m.

FAIR DORM

Members who have graduated 4th grade with animals which need daily care may stay at the dorms during the Fair. Fee: \$5. The dorm is not a 4-H sponsored activity. Dorms belong to the Fair. However, the 4-H office will take names of those interested and fees on behalf of the Fair. Packets will be sent to you before the Fair. Remember, it is a privilege to stay at the dorm. Youth can sign up starting in June by contacting Nancy at the 4-H office. The Fair Board is in need of dorm chaperones.

ENTRY FORM REQUEST

If you plan on entering both in the youth and open fair, please put each division on a separate entry form. Each division (youth, open and senior) are treated separately in the Fair computer program and exhibitors are issued separate exhibitor numbers.

2023 YOUTH TRACTOR & MACHINERY SAFETY TRAINING

Pound Town Hall – Coleman, WI on Thurs/Fri, July 13/14 and 20/21. Cost: \$45/person. 9 a.m. to 3:15 pm each live session day.

NOTE: If these dates are not available for your family, another set of training is being offered in Birnamwood area, planned for July 17, 18, 24, and 25 – contact Scott for more information.

Who Needs To Attend the Training? Any 12 to 15-year old who may need to drive any type of farm machinery on a public road in Wisconsin. Others are

welcome to attend the course, but only those older than 12 will receive certification. Those 16 years old and older without a valid driver's license can also utilize this training to be legal to drive farm machinery on public roads.

Legal Review: In Wisconsin, 14 and 15 year-olds who have successfully passed the Wisconsin Safe Operation of Tractor and Farm Machinery Course can legally drive farm machinery on public roads for their parents or grandparents' farms AND can work for other farms and do the same. 12 and 13-year olds who have completed the course can legally drive farm machinery on public roads only when working for their parents or grandparents' farms. If you employ persons under 15 years or who do not have a driver's license, it is highly recommended that you have them attend the training, whether they drive on public roads or not. You may want to talk to your insurance agent to double-check about requirements based on your insurance policy.

Some Logistics:

- -All participants MUST be in attendance on July 21 for testing. You can miss one of the other days and complete self-study to 'make up' that time, but must be at testing day.
- Participants need to bring their own lunches, a refrigerator will be available for storage. Families are welcome to provide snacks, Scott will have water and/or lemonade and/or milk available.
- The course will emphasize hands-on and skill-building exercises, including first aid and fire safety from local emergency response personnel. We will be analyzing machinery for safety aspects, conducting on-farm safety assessments, and dozens of other activities, along with videos and course material review.

Exploring 4-H for New Families



Learn By Doing



Reprinted with permission from lowa State University Extension and Outreach Since 4-H started in the early 1900s, the idea of "learning by doing" has defined the program. This hands-on process allows youth to understand not only how to do something but also why they're doing it. This model is known as the Experiential Learning

Failure is OK!

One of the biggest challenges (and benefits) of experiential learning is not always being successful immediately. It might be hard to sit back and watch your youth struggle, but it's a valuable lesson. 4-H is supposed to be a place where you can fail in a safe environment. Learning is a process—change from failure is ok!

Support your youth and encourage them! The first arrow in an archery lesson might miss the target, but you'll be amazed how your youth progresses after ten, fifty, one hundred more attempts.

Car Ride Questions

It's pretty common for 4-H members to share what they learned with their peers and the adults leading a project. The learning doesn't end when youth leave the activity and head home! Take time with your 4-H member to reflect on their experience. Ask some questions to see what they learned and to help them think critically about the activity they just did. Reflection is an important part of learning by doing, and you as a caregiver can help support the process. Here are some questions you could ask:

What was the easiest part of the activity? What surprised you?
What were some problems that came up over and over? How did you handle them?
What was the most challenging part of the activity? Why? How did you solve it?
What advice would you give to someone who wants to do this activity?
How can you use what you learned?

Origami Hearts

Have you ever tried origami before? Origami is the art of paper folding. Try to make a heart out of a square piece of paper by following these steps! If you have questions or don't understand a step, ask an adult for help!



Start with a 6" x 6" square piece of paper. If you're using origami paper, put the side with the color pattern face down on the table.

Fold paper in half on the diagonal, bringing top corner to bottom one. Unfold. Fold in half again, bringing right corner to left one. Unfold.

How did it go?

Did you get it right the first time? If you did, great job! If you didn't, try it again! It's normal to not get an origami fold perfect on the first try. Try to see if you can perfect the skill. After you have this one down, try to create some other new folds!
